## **Ernst & Young Study**

- Needed to understand comparative tax burden with passage of Corporate Activity Tax in 2019 (and other taxes)
- Strong belief that lawmakers are not seeing cumulative impact of new taxes
- Third party validation to bolster advocacy efforts
- Objective education a key part of OBI's work
- First study: November 2020
- Refresh/updated study: October 2022
- Report on OBI website



### New taxes / increased taxes

#### **Statewide**

- <u>CAT</u> \$250 plus 0.57% of "taxable commercial activity" in Oregon above \$1 million (began in 2020)
- Insurer premium tax increase (from 1.5% to 2.0%) on premiums (began in 2020)
- Paid Family Medical Leave payroll tax (1% of wages), begins 2023

#### Local

- Portland 1% gross receipts tax, began 2019
- Portland parks property tax, began 2021
- Multnomah Co. business income tax (increase from 1.45% to 2.0%), began 2020
- Multnomah Co. individual income tax for preschool (1.5% to 3.0%), began 2021
- Metro 1% income tax for homeless services, began 2021



# Total effective business tax rates/ Key takeaways

- 52% increase in business taxes paid between 2019 and 2021 (taxes increased by \$1.2 billion)
- TEBTR increased to 5.4% in 2021 from 4.2% in 2019
- Oregon went from 38<sup>th</sup> lowest tax burden, to 21<sup>st</sup> highest
- Additional 32% increase in local tax burden
  - Portland/Metro region has second highest marginal combined income tax rate in nation at 14.7%!
- Oregon's combined state/local "TEBTR" above national average <u>and</u> ID, AZ, UT, WA, and even... CA

# Big challenges...

- Statewide bus tour last August, we heard: Taxes too high, regulation too complex, usable land too scarce/too expensive, lack of understanding or appreciation of business. And <u>lot's</u> of out-of-state recruitment
- More than 80% of Oregon CPAs have at least 1 client actively considering leaving the state (most have several)... not to mention anecdotal data about people and companies leaving, investments not occurring
- Several reasons for this: including regulatory compliance costs, permitting black holes, lack of workforce housing, workforce shortages, burdensome overtime and leave rules, developable land scarcity, rising crime, declining school performance. **And also...**

# What we are doing about it

- Working to STOP new taxes
  - State level (HB 2673, multiple tax "study" bills, "People's Rebate in 2024)
  - Local level (cap gains in Multnomah Co, May 2023)
- Expanding stakeholder partnerships (business and atypical)
- Changing the narrative / OBI's Pro-Growth & Innovation agenda
  - R&D tax credit; CAPEX tax credit; Semiconductor Task Force; rate reforms w/inflation adjustments; estate tax reform; wage and training tax credits; regulatory reform including Business Ombuds Office and Regulatory Efficacy & Audits Commission
- Bring legislators to businesses
  - Monthly manufacturing tours, Summer comprehensive tour
